BY PROCEEDING WITH THIS BOOKING YOU HAVE AGREED TO OUR TERMS AND CONDITIONS

PLEASE NOTE ACCESS TO THE PARK IS BY A SECURITY ACCESS SYSTEM. WE REQUIRE UP TO DATE VEHICLE REGISTRATION NUMBERS TO ENABLE ACCESS.

Bookings are not transferrable. Should you terminate your holiday early, no refund will be given. We reserve the right to terminate holidays due to unforeseen circumstances.

Pitches are not guaranteed and can be altered at any time at the owner's discretion, however a suitable pitch will be allocated.

A strict 5 mph speed limit applies on the park at all times. All drivers must be fully licensed and insured as all road laws apply on the park. Dangerous driving is not permitted and offenders will be asked to leave the park.

One car per pitch, any extra cars to be parked in car park near reception.

No small tents alongside caravan or motorhome unless previously agreed.

Dogs must be kept on a lead on site at all times other than in designated areas. Owners will be responsible for the removal of any fouling in the park. We reserve the right to refuse certain breeds of dog that we consider inappropriate for a family holiday park. Any noisy or aggressive dogs will not be tolerated on site. Owners and dogs will be asked to vacate immediately. No pets to be left unattended at any time in or around units. Children under 16 are not allowed to walk dogs unsupervised.

No private caravan/motorhome sales permitted in the park without the consent of the park owner.

Only urgent messages can be delivered. We will not accept any liability for errors arising from telephone requests of any nature. Please notify reception or wardens immediately when calling out emergency services including any breakdown recovery vehicles etc.

Please notify reception or wardens of visitors or deliveries giving as much notice as possible.

No drainage from caravan or dirty water to be disposed into the ditch.

Portable toilets must be emptied in the disposable points provided. Grey water also to be emptied in the correct point provided. If unsure please see wardens.

For new arrivals check in is strictly from 1pm to 8.30pm

Guests are requested to vacate their pitch by 11.00am on the day of departure unless by prior arrangement.

Parents must be responsible for their children and supervise them at all times. Young children must be accompanied to the toilets/showers.

Play area times: 8.00am to 9.00pm or dusk, whichever is earlier.

No food to be put out for feeding birds, wildlife etc.

Barbecues must not disturb adjoining units. For safety reasons barbecues must not be left unattended and if using disposable ones please see wardens for blocks and disposal. Never use a barbecue in an enclosed space.

Radios etc. to be played unobtrusively.

Chinese lanterns or fireworks are not to be used at any time on the site. Please do not use or erect flags unless permission has been given by the site owner.

Drones are not to be used anywhere on the site except by prior permission of the owner.

Please respect the occupiers of other units on the park and keep noise to a minimum, especially after 9.00pm. The management reserves the right to terminate the booking of any persons whose conduct is detrimental to the park or comfort of visitors. No refund will be given.

Due to regulations the park is for holiday use only, working or trading from the park is not permitted. No sign written vehicles.

No lorries, commercial or converted vehicles allowed on the park without prior arrangement. Unlicensed motorised vehicles i.e. quad/micro scooters are not permitted.

The site owner accepts no liability whatsoever for personal injury, inconvenience, damage or loss to persons or property at any time on the park.

All caravans must be insured whilst on the premises. Insurance of the caravan is the responsibility of the owner- the site owner accepts no liability.

Dulhorn Farm Holiday Park is a family site only. Groups of young people or single sex parties are not accepted unless by prior arrangement. We reserve the right to refuse admission to any person(s).
