TERMS AND CONDITIONS FOR COTTAGES & STATIC

Bookings are not transferable. Should you terminate your holiday early, no refund will be given. We reserve the right to terminate holidays due to unforeseen circumstances. We may on occasion have to change your booking to alternative suitable accommodation.

On booking we require a 20% deposit and the balance to be paid 21 days prior to arrival.
On cancellation refunds will only be considered if accommodation is re-let.

A strict 5 mph speed limit applies on the park at all times. All drivers must be fully licensed and insured, as all road laws apply on the park. Dangerous driving is not permitted and offenders will be asked to leave the park.

Dogs must be kept on a lead on site at all times other than in designated areas. Owners will be responsible for the removal of any fouling in the park. We reserve the right to refuse certain breeds of dog that we consider inappropriate for a family holiday park. Any noisy or aggressive dogs will not be tolerated on our site. Owners and dogs will be asked to vacate immediately. No Pets to be left unattended at any time in or around accommodation. Children under the age of 16 are not allowed to walk dogs unsupervised.

Only urgent messages can be delivered. We will not accept any liability for errors arising from telephone requests of any nature.

Please notify reception or wardens immediately when calling out emergency services, including breakdown or recovery vehicles. Please notify wardens or reception of visitors or deliveries giving as much notice as possible.

Cottages will be ready by 2pm on day of arrival and guests are requested to vacate by 10 am on the day of departure. All damages and breakages must be reported. Charges may apply at the owner's discretion.

Parents must be responsible for their children at all times. Young children must be accompanied to the toilets/showers.

Play areas times: 8am until 9pm or dusk, whichever is earlier.

No food to be put out for feeding birds, wildlife etc.

Barbecues must not be situated inside or near entrances of any cottage or static.

Barbecues must not disturb adjoining guests.

Radios etc. to be played unobtrusively.

Please respect the occupiers of other units on the park and keep noise to a minimum, especially after 9.00 pm. The management reserves the right to terminate the booking of any persons whose conduct is detrimental to the park or comfort of visitors. No refund will be given.

Due to regulations the park is for holiday use only, working or trading from the park is not permitted.

No sign written vehicles. No lorries, commercial or converted vehicles allowed on the park without prior arrangement. Unlicensed motorised vehicles i.e. quad/micro scooters are not permitted.

Chinese lanterns or fireworks are not to be used at any time on the site. Please do not use or erect flags unless permission has been given by the site owner.

Drones are not to be used anywhere on the site except by prior permission of the owner.

No post to be delivered as we are not a residential site.

The site owner accepts no liability whatsoever for personal injury, inconvenience, damage or loss to persons or property at any time on the park.

Dulhorn Farm Holiday Park is a family site only. Groups of young people or single sex parties are not accepted unless by prior arrangement. We reserve the right to refuse admission to any person(s).

For new arrivals, check in strictly no later than 8.30pm.

If guests wish to vacate the park before 8.00 a.m. on the day of departure please inform reception or wardens one day prior. (Subject to conditions)
